## SECTION 5: CRP JUDAISM ON LINE COURSE 2022 - Course 1 from 27 April / Course 2 from 8 June

This course has been specifically designed for admission to schools whose religious authority is the Office of the Chief Rabbi or whose Foundation Body is the United Synagogue, for admission in September 2023. Applicants who wish to establish religious practice priority to these schools can choose to accumulate the CRP in any way they wish and this course would accrue 2 points. The course is open to all applicants and will consist of 6 sessions of 30 minutes, covering topics relevant to Jewish customs and practices, festivals, kashrut, etc. All of them need to be completed in order to satisfy this section. Courses will run in April and June 2022.
