

## **Provider Access Policy Statement**

**Ownership: JFS**

**Date Updated: November 2023**

This section of the policy explains the school's arrangements for managing the access of providers to pupils at the school for the purposes of giving them information about the provider's education or training offer.

JFS is committed to ensuring there is an opportunity for a range of education and training providers to access students, for the purpose of informing them about approved technical education qualifications and apprenticeships.

JFS endeavours to ensure that as the number of apprenticeships rise every year, all our young people have a full understanding of all the options available to them post-16 and post-18 including wider technical education options such as T-Levels and Higher Technical Qualifications

### **School commitment:**

JFS policy for Access to other education and training providers has the following aims:

- To further develop the knowledge and awareness of our students of all career pathways available to them, including technical qualifications and apprenticeships.
- To support young people to be able to learn more about opportunities for education and training outside of school before making crucial choices about their future options.
- To reduce drop out from courses and avoid the risk of students becoming NEET (Young people not in education, employment or training).
- To act impartially, in line with the statutory duty, not showing bias towards any route, be that academic or technical.

### **Student entitlement:**

Students in years 7-13 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options evenings, assemblies and group discussions and taster events.
- To understand how to make applications for the full range of academic and technical courses. Management of provider access requests Procedure.

## **Development**

This policy has been developed and is reviewed annually by the Careers Leader and Line Manager (**Ella Buckle – Director of Sixth Form**) based on current good practice guidelines by the Department for Education.

## **Links with other policies**

It supports and is underpinned by key school policies including those for Careers, Child Protection, Equality and Diversity, and SEND.

## **Equality and Diversity**

Access to other providers is available and promoted to allow all students to access information about other providers of further education and apprenticeships. **JFS** is committed to encouraging all students to make decisions about their future based on impartial information.

## **Opportunities for access**

A number of events, integrated into the school careers programme, will offer providers an opportunity to come into school to speak to pupils and/or their parents. Please speak to the Head of Careers to identify the most suitable opportunity for you. The school policy on safeguarding sets out the school's approach to allowing providers into school as visitors to talk to our students. Students may also travel to visit another provider as part of the trip to be organised in partnership with **JFS**.

## **Live/Virtual encounters**

**JFS** will consider live online encounters with providers where requested, and these may be broadcast into classrooms or the school assembly hall. Technology checks in advance will be required to ensure compatibility of systems.

## **Parents and Carers**

Parental involvement is encouraged, and parents may be invited to attend the events to meet the providers.

## **Management**

The Careers Leader coordinates all provider requests and is responsible to his/her senior management line manager.
